Dorcann a dhath, ag cur éifeacht aeistéitiúil uathúil i láthair. Fágann an próiseas seo go bhfuil an t-adhmad níos cobhsaí, go laghdaíonn sé leathnú nó crapadh de bharr athruithe taise, agus go bhfeabhsaíonn sé friotaíocht i gcoinne lotnaidí agus tubaistí nádúrtha. Meastar gur ábhar atá neamhdhíobhálach don chomhshaol é adhmad carbónáite toisc nach mbraitheann a tháirgeadh ar leasaitheigh cheimiceacha.



Úsáidtear adhmad poibleog carbóinithe go forleathan sna réimsí seo a leanas mar gheall ar a fheidhmíocht den scoth:

- Réimsí Eile: Lámhcheardaíocht, Uirlisí Ceoil, Ábhair Pacáistithe, etc.
