

Carbonized poplar wood ay isang uri ng kahoy na sumasailalim sa high-temperature heat treatment, na nagpapataas ng tibay at corrosion resistance. Nagdidilim ang kulay nito, na nagpapakita ng kakaibang aesthetic effect. Ang prosesong ito ay ginagawang mas matatag ang kahoy, binabawasan ang pagpapalawak o pagliit na dulot ng mga pagbabago sa halumigmig, at pinapabuti ang paglaban sa mga peste at natural na sakuna. Ang carbonized na kahoy ay itinuturing din na isang materyal na palakaibigan sa kapaligiran dahil ang produksyon nito ay hindi umaasa sa mga kemikal na preserbatibo.



Ang carbonized poplar wood ay karaniwang ginagamit sa panlabas na kasangkapan, bakod, deck, at landscaping. Ang matatag na pagganap nito ay ginagawang angkop din para sa paggamit sa paligid ng mga swimming pool at iba pang mga kapaligiran na may mataas na kahalumigmigan.
